EXECUTIVE ORDER NO. 01 Series of 2024

AN ORDER CREATING THE MUNICIPAL POPULATION AND DEVELOPMENT COORDINATING COMMITTEE IN THE MUNICIPALITY OF AMULUNG, CAGAYAN

WHEREAS, the Commission on Population (POPCOM) is the mandated agency in coordinating and planning for the Philippine Population Development Program (PPDP);

WHEREAS, one of the PPDP strategies is the integration of population dynamics in sustainable development initiatives particularly in national and sub-national development planning and policy development;

WHEREAS, the Municipality of Amulung, Cagayan has the mandate by virtue of the Local Government Code (LGC) to ensure the general welfare of its constituents and manage the development of its people and the locality under its jurisdiction;

WHEREAS, local development planning is a mandated function of the LGU and a critical process and tool to ensure the general welfare of the population as mandated by the Local Government Code;

WHEREAS, in order to ensure that local development is centered on the needs of the people, there is a need to integrate population and development (POPDEV) interrelationships and dynamics in each of the steps of the development planning process;

NOW, THEREFORE, I, **ELPIDIO R. RENDON**, Mayor of the Amulung, Cagayan by virtue of the powers vested in me by law, do hereby order the creation of the MUNICIPAL POPULATION AND DEVELOPMENT COORDINATING COMMITTEE IN THE MUNICIPALITY OF AMULUNG, CAGAYAN


