RECONSTITUTING THE COMPOSITION OF THE MUNICIPAL DEVELOPMENT COUNCIL

WHEREAS, Section 106 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", mandates Local Government Units to have a comprehensive multi sectoral development plan to be initiated by its development council and approved by its Sanggunian;

WHEREAS, the creation of Municipal Development Council will provide direction, control and coordination in the development efforts of the Local Government Units;

WHEREAS, the Municipal Development Council is customarily constituted and without exception whether major changes exist in the administration due to local elections;

NOW THEREFORE I, ELPIDIO R. RENDON, Municipal Mayor of Amulung, by virtue of the powers vested in me by law, do hereby order:

Section 1. Organization and Composition. The Municipal Development Council is hereby organized and shall be composed of the following:

Section 2. Functions. Pursuant to the provisions of the Local Government Code of 1991, the Municipal Development Council shall exercise the following functions:

1. Formulate long term, medium term, and annual socio-economic development plans and policies;
2. Formulate the medium term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote private investment capital;
5. Coordinate, monitor, and evaluate the implementation of development programs and projects;
6. Create sectoral or functional committees that will assist the Council in the performance of its functions; and
7. Perform such other functions as may be provided by law and competent authority

Section 3. Executive Committee. The Executive Committee of the Municipal Development Council is hereby constituted and shall be composed of the following:

Section 4. Functions. The Executive Committee shall exercise the following power and functions:

1. Ensure that the decision of the council is faithfully carried out and implemented;
2. Act on matters requiring immediate attention or action by the council;
3. Formulate policies, plans, and programs based on the general principles laid down by the council; and
4. Act on matters that may be authorized by the council

Section 5. Sectoral or Functional Committees. The Sectoral Committee of the Municipal Development Council is hereby constituted and shall be composed of the following:

Section 6. Functions. The Sectoral and Functional Committees shall exercise the following powers and functions:

1. Provide the MDC with data and information essential to the formulation of programs, projects, and activities;
2. Define sectoral and functional objectives, set targets and identify PPAs for the particular sector;
3. Collate and analyze information;
4. Conduct public hearing on vital issues affecting the sectors;
5. Coordinate planning, programming, and implementation of PPAs with each sector
6. Monitor and evaluate programs and budgets;
7. Performs such other functions as may be assigned by the MDC

Section 7. Secretariat. There is hereby constituted for the MDC a Secretariat which shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions. The MDC may avail of the services of any NGO, educational or research institution for this purpose.

The Secretariat shall be headed by the Municipal Planning and Development Coordinator and members shall be selected by the Head of the Secretariat from among the employees of the Local Government Unit and those of supporting line government agencies as well as non-government organizations.

Section 8. Effectivity. This Executive Order shall take effect immediately.
