AN ORDER REORGANIZING THE MUNICIPAL NUTRITION COUNCIL (MNC) IN THE MUNICIPALITY OF AMULUNG

WHEREAS, it is the policy of the State to protect and promote the right of the people to health, and instill health consciousness among them;

WHEREAS, in support of this state policy, the Municipal Nutrition Council is created to provide a baseline data on the nutritional status and needs of the people of Amulung;

WHEREAS, the Council will assess and examine the health and nutritional status and needs of the municipality based from the baseline data;

NOW, THEREFORE, I ELPIDIO R. RENDON, by virtue of the powers vested in me by law and as the Local Chief Executive of the Municipality of Amulung, do hereby order:


Section 1. Title. Reorganization of the Municipal Nutrition Council in the municipality of Amulung.

Section 2. Composition. The Municipal Nutrition Council shall have the following composition:

Section 3. Duties and Functions. The Municipal Nutrition Council shall have the following duties and functions:

- a. Responsible for planning, conducting, and monitoring programs necessary to carry out the goals and purpose of the Council;
- b. Provide baseline data on nutritional status and needs of the people in the municipality in aid of legislation;
- c. Promote nutrition education activities in the municipality;
- d. Create awareness in the municipality about available health services and entitlements;
- e. Formulate the Municipal Nutrition Action Plan based on the assessment on the situation and priorities in the community; and
- f. Perform such other functions as may be mandated by law

Section 4. Secretariat. There shall serve a Secretariat for the Municipal Nutrition Council which shall handle the administrative and technical activities of the Council. Specifically, the secretariat shall prepare plans and programs for the consideration of the Council; supervise, direct, and monitor, for the Council, implementation for the approved policies, plans, and programs; undertake liaising and coordination of activities with appropriate agencies of the government and provide a forum for inter-disciplinary dialogue and deliberation.

Section 5. Meetings. The Council shall meet at least quarterly, without prejudice on the part of the Chairperson to call for a meeting when deemed necessary.







Section 6. Term of Office. The term of office of those who compose the Municipal Nutrition Council shall be tree (3) years from the assumption to office. Assumption of office shall commence on the date of this order.

Section 7. Effectivity. This order shall take effect on February 8, 2024 and copies of this order shall be furnished to all concerned for their information and reference.
