EXECUTIVE ORDER NO. 04 SERIES OF 2024

"AN ORDER REORGANIZING THE MUNICIPAL ANTI-DRUG AND ABUSE COUNCIL OF THE MUNICIPALITY OF AMULUNG"

WHEREAS, the constitution mandates that the government shall promote quality of life of the people towards this end, section 16 the republic Act 7610, otherwise known as the Local Government Code of 1991, provides that Local Government Unit shall pursue undertaking to improve public morals and maintain peace and order among the equally significant concerns;

WHEREAS, pursuant to DILG Memorandum Circular No. 98-227 and 98-236 all cities, municipalities and barangays shall ensure that their Anti-Drug Councils (ADAC) are organized;

NOW THEREFORE I, ELPIDIO R. RENDON, Municipal Mayor of Amulung, Cagayan by the power vested upon in me do hereby order:

SECTION 1. TITLE. "ORDER REORGANIZING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL OF THE MUNICIPALITY"

4. Conduct periodic drug abuse prevention program.
5. Perform such other function as may be mandated by law.


SECTION 4. MEETING
