"A RESOLUTION APPROVING THE EXTENSION OF BUSSINESS ONE STOP SHOP (BOSS) UNTIL JANUARY 31, 2024"

WHEREAS, Section 167 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "unless otherwise provided in this code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each, subsequent quarter, as the case maybe;

WHEREAS, Sanggunian concern may, for a justifiable reason of cause, extend the time payment of such taxes, fees and charges without surcharges of penalties, but only for a period not exceeding (6) months";

WHEREAS, pursuant to RA 11032, otherwise known as "An Act Promoting Ease of Doing Business and Efficient Government Service Delivery Act of 2018 that aims the streamline the current systems and procedures of government services";

WHEREAS, the Municipal Government of Amulung heeds the public clamor to extend the period to secure business permits and licenses and to give ample time to the Business Permittees and Licensees of the Municipality of Amulung.

WHEREFORE, on motion of Hon. Christopher C. Marcos duly seconded by all the members present;

RESOLVED AS IT HEREBY RESOLVED to approve the extension of Business One Stop Shop (BOSS) until January 31, 2024.
